Motion by Willrich, 2nd by Ellerman to approve Digital Stew invoice for payment. Ayes: Cross, Willrich, Ellerman and Stevens. Abstain: MacConnell.

Motion by Ellerman, 2nd by Cross to approve Resolution 2008-5 – disposing of and selling the City-owned property at the northeast corner of Sugar Grove Avenue and Quinlan Avenue to James Woodsmall for \$50,000, and authorizing Mayor and Clerk to deliver Quit Claim Deed upon receipt of purchase price. Roll call 5-0.

Motion by Willrich, 2nd by Stevens to approve contract with MPS Engineers to plug monitoring wells – not to exceed \$2,325 for City-owned property at the northeast corner of Sugar Grove Ave. and Quinlan Ave. Roll call 5-0.

Motion by Cross, 2nd by MacConnell to direct City attorney to prepare an ordinance for a 10% sewer rate increase effective May 1, 2008. All ayes.

City Engineer Veenstra gave a presentation on the State rules governing annexation. Motion by Stevens, 2nd by MacConnell to direct Ellerman, Cross and Hambleton to determine services the City might offer and possibly contact certain land owners regarding annexation. All ayes.

Council directed City attorney to prepare a resolution exempting certain areas of the City from the storm water utility fee.

Motion by Ellerman, 2nd by Stevens to approve tax abatement applications. All ayes.

Motion by Willrich, 2nd by MacConnell to set public hearing on 2008-2009 City budget for March 11, 2008.

Institute for Decision Making will conduct an Economic Development workshop on February 18th at 6:00 PM at the library.

Mayor Hambleton reported on property land values and NIMs training. The City is in the process of becoming a certified Storm Ready City. The next annexation meeting with Adel and Waukee will be on February 14th.
